



## Colvin Crew Recovery No. 35 – Summer 2019

Township 40 - Raquette Lake, Hamilton County, New York

RE: Recovery No. 35 for the Colvin Crew - Visit the Township 40 southeast corner, north of the Marion River between Raquette Lake and Utowana Lake

**Recovery Date: Saturday - August 24 , 2019**

Dear Crew,

The recovery planned for the 24th of August, 2019 will be a recovery of the Township 40 corner marker. This will include both boating on the water ( in your own canoe, kayak or boat) and a bit of hiking (which will require some bushwacking off trail). The water portion, from Golden Beach boat launch to the trailhead on the Marion River, will take about two and half hours by kayak. There is a small sandy spot to land the boats at the trailhead. The hiking portion will be about a mile in from the river.

Note: The winds across Raquette Lake can be rather strong at times causing rougher waters and may impact the amount of time spent on the water if we follow the shoreline.

We will meet at 9:30 AM at the boat ramp at the New York State Golden Beach Campground and Day Use Area, ( 43 49 00.97534N, 074 35 38.63379W ) for access to the lake. There is an \$8 fee to obtain a pass for park access and the boat ramp parking area. When last checked, there were campsites available at the aforementioned campground for this weekend. There may also possibly be accommodations available in the town of Old Forge to the west on Route 28.
